Resolution to Authorize the Defense and Indemnification of the Members and Employees of the Stony Brook Regional Sewerage Authority

**Resolution No. 2025-103** 

WHEREAS, there exists a need to protect each past and present member and employee of the Stony Brook Regional Sewerage Authority ("SBRSA") from the monetary costs of fines, penalties, damages, settlements, costs, and legal fees associated with the defense of any civil or criminal actions which may be brought against the SBRSA, or any such member or employee, as the

result of any action(s) or omission(s) relating to the duties of such member or employee to the SBRSA; and

WHEREAS, the SBRSA desires to provide such protection for each past and present member and employee from the financial consequences of any such civil or criminal action to the extent permitted by law and, therefore, provided that such alleged action or omission does not constitute actual fraud, actual malice, willful misconduct, or an intentional wrong in the judgment of the SBRSA;

**NOW, THEREFORE, BE IT RESOLVED** by the Stony Brook Regional Sewerage Authority as follows:

- 1. The SBRSA shall, to the extent permitted by law, provide a defense and indemnification to the past and present members and employees of the SBRSA and, therefore, shall pay or otherwise reimburse each past and present member and employee of the SBRSA for all fines, penalties, damages, costs and legal fees associated with any civil or criminal action which may be brought against such member or employee based upon an act or omission of that member or employee arising out of and directly relating to the lawful exercise of his or her official duties or under color of his or her authority.
- 2. In any case where the SBRSA provides a defense to a member or employee, it is authorized and directed to make direct payments to counsel or reimburse the member or employee for the costs associated with his or her defense upon the approval by the SBRSA of proper vouchers submitted therefore, but in no case shall the SBRSA be authorized to pay or reimburse for legal fees and expenses exceeding those customarily charged for legal services in the defense of such actions.
- 3. For the purpose of this Resolution, the term "member" shall include any and all persons appointed by the governing bodies of the constituent municipalities pursuant to N.J.S.A. 40:14A-4
- 4. Any person seeking the provision of a defense and indemnification under the policy enunciated in this Resolution shall give prompt notice to the SBRSA of the pendency of any such civil or criminal action for which payment or reimbursement is sought, at which time the SBRSA shall, by Resolution, implement the provisions set forth herein.
- 5. It is within the sole discretion of the SBRSA, in any action where the provision of such a defense and indemnification is sought by a member or employee, to:
  - a. Provide a defense by an attorney chosen by the SBRSA;
  - b. Provide a defense by an attorney of the member or employee's choosing; or
  - c. Assert the SBRSA's right under any appropriate insurance policy that requires the insurer to defend and indemnify.

- 6. Notwithstanding the foregoing, the SBRSA may refuse to provide for the defense or to indemnify any past and present member or employee of the SBRSA in any action referred to above or may recover any amounts paid on behalf of such member or employee for such defense if in its sole discretion, it has reason to conclude that the act or omission was:
  - a. Not within the scope of such member or employee's duties or was carried out in an individual capacity;
  - b. The subject matter of any action brought by the SBRSA against the member or employee;
  - c. A violation of the Local Government Ethics Law (P.L. 1991, c. 29); or
  - d. Due to actual fraud, actual malice, willful misconduct, or an intentional wrong.
- 7. In the event a contested matter, to which this Resolution is applicable, is resolved by way of settlement, the SBRSA may take into account the facts, circumstances and allegations that led to the settlement in its determination of whether it may, subject only to the provisions of paragraph 6, indemnify such past and/or present member(s) and/or employee(s) against whom such settled claims had been made.
- 8. It is the intention of this Resolution to set forth the policy of the SBRSA with respect to the defense and indemnification of persons associated with the SBRSA in the management of its affairs and businesses to the maximum extent permitted by law, and if any provision hereof or the application thereof to any person or circumstance is held invalid by a court of competent jurisdiction, such invalidity shall not affect other provisions of this Resolution and to this end, the provisions hereof are declared to be severable.
- 9. The policy set forth in this Resolution shall take effect immediately, but shall automatically expire unless re-authorized at each annual reorganization meeting of this Authority.

Dr. Downey requested that Resolution 2025-117, Authorizing Execution of a Settlement Agreement Resolving Civil Administrative Penalties Issued by NJDEP Relevant to Pennington WWTP Permitted Effluent Discharge Limitation Exceedance, be presented for approval by Mr. Stewart during the Operation section discussion.

Dr. Downey reported that Ms. Bhosle presented to the West Windsor Council on the recently proposed settlements between 3M and DuPont with the State of NJ. Following the presentation, West Windsor Council indicated that they intend to issue a resolution opposing these settlements due to our concerns over the tremendous cost and burden that municipalities and taxpayers will need to underwrite should SBRSA encounter future PFAS liabilities.

To issue a formal opposition, West Windsor must file with the courts by December 10, 2025. West Windsor requested that the Authority provide a sample resolution for their consideration and use. Ms. Bhosle thanked everyone for their support in this matter.

Mr. Smith reported that the current 12-month average daily flow at River Road WWTP is 7,833,412 gpd, with 1,410,245 gpd of inoperative flow, leaving an available capacity of 3,816,343 gpd. The current 12-month average daily flow at the Hopewell WWTP is 195,679 gpd, with zero gpd of inoperative flow, leaving an available capacity of 104,321 gpd. The current 12-month average daily flow at Pennington WWTP is 238,197 gpd, with 23,026 gpd of inoperative flow, leaving an available capacity of 183,777 gpd.

Mr. Smith reported that flowmeter verifications were completed by staff on October 31, 2025. All flowmeters were within  $\pm 5\%$ .

Mr. Smith reported that, from October 21, 2025, through October 31, 2025, the Hopewell WWTP influent flow meter was bypassed to accommodate work under Contract 19-1 (Hopewell WWTP

Upgrade Project). The data recorded by the meter during this period was erroneous. Accordingly, influent flow totalizer data for this timeframe were substituted with effluent meter data.

## 651.06 Approval/ Extension Requests and Actions

Nothing to report for this reporting period.

## 651.07 Regulatory Report

There were no other Board member comments on the Regulatory Report. For information, the following Regulatory Report is included in the meeting minutes.

## **Discharge Monitoring Report (DMR)**

The discharge monitoring reports for September 2025 were submitted. No violations were reported.

October 2025 Total Phosphorus Action Level Report was submitted to NJDEP by email on November 6, 2025.

The annual effluent bioassay for River Road, Hopewell and Pennington facilities were conducted during the week of October 6, 2025, and the results of >100% for River Road and Hopewell and 93.6% for Pennington were electronically reported to NJDEP on October 28, 2025.

## Residuals Discharge Monitoring Report (RDMR)

The August 2025 RDMRs were submitted. All River Road parameters were in compliance with the Title V Air Permit requirements.

The September 2025 RDMRs are currently being reviewed.

## **Air Reporting**

The 3rd Quarter 2025 Incinerator Sludge Metals Report was submitted to NJDEP on November 6, 2025. There were no exceedances of the monthly, 12-month weighted average, and 15-month rolling average metals concentration limits. There were also no exceedances of the 12- month rolling average emission limits for lead and mercury.

The 3rd Quarter 2025 Excess Emissions and Monitoring Performance Reports (EEMPR) were submitted to the NJDEP and EPA. Incinerators No. 1 and No.2 operated with the Regenerative Thermal Oxidizer (RTO). Incinerator #2 operating with RTO (OS28) had 0.08 hours of excess Oxygen emissions (Oxygen <3.0%). Carbon Monoxide (CO) concentrations during these periods were less than 100 ppmdv at 7% Oxygen.

The 2025 Annual Ozone Season (May 15 through September 15) report was included in the 3rd quarter 2025 EEMPR. No fuel oil was used during the 2025 Ozone season.

The 2025 Q3 Quarterly Report, detailed in paragraph 28 of the 2022 Consent Decree, was submitted on October 28, 2025. A copy of the report was provided without attachments.

## 651.08 <u>Safety</u>

There were no Board member comments on the Safety Report. For the record, the following Safety Report is included in the meeting minutes.

#### **Accidents:**

As of November 6, 2025, the Stony Brook Regional Sewerage Authority has gone 97 consecutive days without a "Lost Time" accident. An up-to-date graph depicting the historic annual trends of "Lost Time" and "No Lost Time" accidents and injuries was provided.

## **Inspections:**

The safety committee and plant staff continue to work through Priority 1 Safety Items.

## **Training:**

During this reporting period, staff attended the following training program provided by the MEL Safety Institute.

• Practical Leadership – 21 Irrefutable Laws

#### Miscellaneous

Because of the compressed holiday schedule, the safety meeting was held after the board reports were submitted, so the safety meeting minutes are not included for this month. Meeting minutes will be attached to next month's board report.

## 651.09 Litigation

Ms. Alexander reported that there is nothing new to report in this period.

#### **651.10 Operations Report**

#### **River Road Facility**

Mr. Stewart reported that the River Road Facility operated well during this reporting period.

Nitrification Settling Tank Cleaning and Inspection

During the week of November 3, 2025, Nitrification Settling Tank #3 was dewatered and cleaned. While the tank was out of service, it was inspected for any mechanical issues. Following the inspection, which had found no mechanical issues, the tank was put back into service on November 14, 2025.

## **Upstream Facilities**

Both Upstream Facilities operated well during this reporting period.

Disk Filter Cleaning and Maintenance

During the week of November 3, 2025, the disc filters at the Pennington WWTP were thoroughly cleaned and flushed as part of our monthly maintenance program. No mechanical issues were observed, and the stainless-steel mesh sections of the discs are in good condition.

#### NJDEP NOV

On March 3, 2025, staff received a call from Stony Brook's NJDEP Water Compliance and Enforcement officer regarding a potential permit violation from the August 2024 Discharge Monitoring Report (DMR) submitted in September 2024. A summary of the event is presented below:

Heavy localized rain events resulted in high flows at the Pennington Treatment Plant on August 6, 2024, and into August 7, 2024. SBRSA sampled the plant effluent on both days and collected flow data from the Supervisory Control and Data Acquisition (SCADA) system. According to the SCADA System, the flow was 0.225 MGD on August 6, 2024, and 0.506 MGD on August 7, 2025. The loading calculations based upon the SCADA flow data was within the permitted limits for both the weekly and monthly averages.

During the monthly review of the daily flow data, SBRSA staff later discovered that the influent and effluent flow meters were submerged on the affected dates. Flow data were adjusted using a secondary flow meter. In September, SBRSA then used the adjusted flow data to recalculate the BOD loading for weekly and monthly averages. The new flow data adjusted the August 6 flow from 0.225 MGD to 0.723 MGD. Additionally, the flow data for August 7 was adjusted from 0.506 MGD to 0.811 MGD. Based on the new flow data, the loadings increased by more than 50%. The adjusted loading calculations were determined to be 8.91 KG/Day, which exceeded the weekly 8.6 KG/Day and monthly 5.7 KG/Day limits for BOD.

SBRSA contacted the NJDEP Hotline on March 3, 2025, the same day SBRSA was notified of the effluent limitation violation, to advise NJDEP of the violation due to excessive wet weather, and submitted an Affirmative Defense on March 7, 2025.

NJDEP responded to the requested Affirmative Defense dated March 26, 2025, and denied the request.

Staff received a Settlement Agreement dated October 10, 2025. The Agreement outlines the previously mentioned exceedance, along with a monetary penalty in the amount of \$1,000.00. A Resolution pertaining to the Agreement will be presented in the New Business Section of the

Board Book. Changes to data review have been implemented with Operations staff regarding wet weather events and sampling schedules. Additionally, alarms have been added to the plant SCADA system to trigger if daily flows exceed permit limits for both Upstream facilities.

Mr. Stewart presented for approval Resolution 2025-117, Authorizing Execution of a Settlement Agreement Resolving Civil Administrative Penalties Issued by NJDEP Relevant to Pennington WWTP Permitted Effluent Discharge Limitation Exceedance.

Resolution 2025-117 was moved by Mr. Morehouse, seconded by Mr. Patel.

A discussion occurred about the incident that led to the penalty.

Resolution 2025-117 was passed by roll call vote of 6 to 0. Resolution 2025-117 follows.

Mr. Stewart reported on the following.

Hopewell Upgrade Project – Bypass Pumping

On October 22, a temporary bypass pumping system was put online at the Hopewell WWTP to facilitate the construction work at that location. Two (2) pumps, each with a 6" suction and discharge, were deployed upstream of the influent wet well. The pumping system will convey wastewater from the influent channel to the existing Primary Settler Tanks. While the influent wet well is being bypassed, CMS will clean and inspect the influent wet well and will replace the influent pumps, valves, and necessary piping sections. The bypass operation will be in place for 4-6 weeks.

## Asset Management

## Asset Management Plan

Phase II of SBRSA's Asset Management Plan (AMP) is underway. CDM Smith representatives were onsite the week of October 20 to develop an asset hierarchy. A draft list of the asset hierarchy was received on November 7 and is currently under review by staff. Phase II scope of work is planned to be completed over a nine (9) month period ending in the spring of 2026, with additional workshops as the work progresses.

## **Inventory Audit**

The ongoing audit of plant inventory stands at approximately 82% complete, with a target goal of 100% completion by year's end. After the River Road WWTP inventory audit has been completed, the Upstream facilities will be addressed in the next phase. Lastly, the pumping stations will be reconciled to complete the inaugural audit. As the audit progresses, controls will be implemented to ensure continuing accuracy with both the CMMS and in field inventory values.

## Odors

Staff have received one (1) odor complaint since the last monthly Operations Report. The total number of odor complaints received year to date is four (4). A historical record of odor complaints since January 1999, as well as a breakdown of the type and location of odor complaints received year to date, was provided in the report.

A discussion took place regarding the odor complaint reported near Barbara Smoyer Park on Herrontown Road in Princeton.

The reported quantity of liquid sludge is 4% below the budgeted amount; sludge cake was 28% above the budgeted amount, and gray water was 14% above the budgeted amount for October 2025.

## 651.11 Maintenance

There were no Board member comments on the Maintenance Report. For information, the following Maintenance Report is included in the meeting minutes.

## **Work Order/Preventative Maintenance Order Summary**

Maintenance successfully completed twenty-eight (28) work orders and sixty (60) preventive maintenance orders. Currently, there are four (4) open work order requests and seven (7) outstanding preventative maintenance orders that are more than ten (10) days overdue. Open and completed work orders, as well as preventative maintenance orders, are tracked and illustrated on the graphs provided.

## **Major Maintenance Repairs:**

On October 22, 2025, the Pennington Treatment Plant Orbal 1 Drive No. 3, which powers the aeration discs, was taken out of service for a scheduled gearbox replacement. The drive-mounted gearbox had developed an oil leak from the main shaft seals, requiring removal and replacement. A spare gearbox had been acquired in advance to minimize downtime and maintain the process. Once the old gearbox was removed, the new gearbox was installed, aligned, and connected to the drive motor. After completing the installation, proper rotation and oil levels were verified. The removed gearbox will be reconditioned and added back to inventory. On October 22, 2025, the Orbal 1 Drive No. 3 Aerator was returned to full service.

On October 29, 2025, the Hopewell Treatment Plant Orbal Tank 1, Drive 2, was reported to have shut down on motor overload. After resetting the overloads, inspection revealed metal filings around the base of one of the pillow block bearings. A replacement was determined necessary, and a spare bearing was sourced from inventory. The Orbal Drive was locked out and dismantled for repair. The worn bearing had seized onto the shaft and could not be removed using a puller, so it was carefully cut off to prevent further damage to the shaft. A new bearing and coupling were then installed, the bearing was greased, and the drive was reassembled, aligned, and tested. On October 29, 2025, Orbal Tank 1, Drive 2, was returned to full operation.

On October 31, 2025, the Receiving Bin Screw Drive #6 was reported to have two of its three screws not turning. Upon inspection, the failure was traced to worn gear teeth on the driven tail gears. The drive was promptly taken out of service and locked and tagged out. Two replacement gears were sourced from inventory, while the damaged gears were removed and lowered for replacement. Once the new gears were installed and properly adjusted, the gear housing was

reassembled, filled with lubricating oil, and secured. The Receiving Bin Screw Drive #6 was tested and returned to full operation on October 31, 2025.

On October 27, 2025, the Nitrification Return Sludge Pump #3 was taken out of service for a pump frame replacement. The original carbon steel frame had experienced significant corrosion due to constant exposure to moisture. After locking and tagging out the system and securing the suction and discharge valves, Shafts and Sleeves Inc. began disassembly of the pump, motor, and associated piping. The VFD cabinet was moved aside, and the corroded frame was disconnected from the floor anchors and transported to the machine shop to serve as a template for fabricating a new stainless-steel frame. While the new frame was being fabricated, the 40 HP pump motor was sent out for reconditioning. Upon completion, the new stainless-steel frame was lowered into the basement, requiring minor field modifications to accommodate the pump components. Once anchored in place, the frame was grouted and finished before reinstalling the pump, motor, and piping. The Nitrification Return Sludge Pump #3 frame installation was completed, and the system was restored on November 6, 2025.

## **651.12 Construction Report**

Mr. Doelling reports that five (5) annual advice contracts are being presented for approval. Staff requested proposals from Chevron Barry Engineering Corporation, ELECSYS Engineering Group, PLLC, Kleinfelder, Inc., One Water, and Trinity Consultants, Inc. for the 2026 Annual Advice Contracts.

Staff recommended approval of the 2026 annual advice contract based on the consultant's expertise, knowledge, and, most importantly, familiarity with the SBRSA facilities. The table below shows the 2025 contract amount, the amount spent as of October 2025, and the 2026 contract amount.

Mr. Doelling reported that the Operations Building HVAC Upgrade Design project was advertised for bids on October 28, 2025. A Pre-bid meeting is scheduled for November 18, 2025. Bid opening date is December 9, 2025.

There were no other Board Member comments on the Construction Report. For the record, the following construction report is included in the meeting minutes.

#### Studies/General

**River Road WWTP Phosphorus Impact Modeling Study:** One Water Consulting (OWC) is awaiting laboratory results from the samples collected, which are expected within the next month. Once received, OWC staff will analyze the data and prepare a summary memo that is anticipated for completion by the end of this year.

The PACL injection systems at both the River Road WWTP and the Pennington WWTP (upstream of Lake Carnegie) were operational through October 31, 2025. The systems have been shut down for the winter season. See the Operations Report for additional details.

*NJPDES Permit:* The NJPDES permit renewal for Pennington WWTP was submitted on October 19, 2025. The application was deemed administratively complete on October 312025 and has been forwarded to the NJDEP Bureau of Surface Water and Pretreatment Permitting for technical review and processing.

**Pump Station Substation Replacement Study:** Staff received the final report from ELECSYS on November 3, 2025. Staff have requested a proposal from ELECSYS for the design of the South Brunswick Pump Station substation upgrade.

**Dewatering Alternatives Evaluation / Belt Filter Press Replacement Study:** SBRSA is coordinating onsite pilot testing of two selected sludge dewatering technologies; the screw press and the rotary press. Pilot testing is not recommended during the winter months due to weather conditions. SBRSA is planning to schedule the pilot testing in April 2026. In the meantime, SBRSA will seek to have a full inspection performed on the three existing belt filter presses.

Analysis of Receiving Bin Screw Failures: Staff continues to review and discuss options for repair or replacement of the receiving bins.

**2026** Annual Advice Contracts: Staff requested proposals from Chavond-Barry Engineering (CBE), ELECSYS, Kleinfelder, One Water Consulting (OWC), and Trinity Consultants for the 2026 Annual Advice Contracts.

The proposals were requested from the consultants through the "No Political Contributions Allowed" process and as outlined in SBRSA's Resolution 2017-03. Staff recommends approval of the 2026 annual advice contracts based on the consultant's "expertise, knowledge, and most importantly, familiarity with the SBRSA facilities."

The following table summarizes the amount spent on each advice contract in 2025 (up to the end of October). All contracts are on a time charge basis. Incinerator Operator training will be provided as a fixed price contract. Each consultant has provided the required Pay-to-Play forms.

#### **Design**

Fly Ash Slurry Pump Suction/Discharge Header Rehabilitation and Process Drain Pump No. 3 Upgrade (Project 24-1): The Process Drain Pump No. 3 Project and the Fly Ash Slurry Pump Header Rehabilitation Project both require a shutdown of the process drain wet well. As such, SBRSA finds value in combining these two projects into a single bid. A combined bid is in preparation and is expected to be advertised within the next 2-3 months.

**River Road WWTP Main Substation Replacement or Rehabilitation Design:** The design work is proceeding well. SBRSA staff anticipate having draft plans for review by the end of this year.

**RTO Media and Force Draft Fan Replacement Project:** Staff are negotiating with two contractors and anticipate reviewing quotes in November/December this year. SBRSA anticipates replacing the media prior to the 2026 stack test; however, the force draft fan replacement will likely proceed after the stack test performance.

Millstone Pump Station Influent Screening Improvements Project: Kleinfelder continues to advance the design for this project. Design efforts remain on track, with ongoing coordination between staff and the consultant team to ensure project requirements are fully addressed.

*Meter Station No.6 Rehabilitation:* Van Cleef Engineering Associates (VCEA) has finalized the design plans and technical specifications for the project. The project was advertised for bidding on November 11, 2025. A pre-bid meeting is scheduled for November 18, 2025. Bids will be opened on December 4, 2025.

*Nitrification Aerator No. 6 Structural Repair:* Kleinfelder is proceeding with the design. The structural model has been completed, and the team is continuing to develop drawings and stainless steel specifications. Staff anticipate receiving a draft set of drawings and specifications in December 2025.

#### Construction

Contract 20-2 River Road Sludge Storage Hopper Feed Screw Replacement Project: Staff continues to coordinate with BR Welding on submittals. On-site construction work is scheduled to commence following the 2026 stack test.

Contract 22-4 Hopewell WWTP Upgrade: The project is approximately 61% complete by value and 86% complete by contract time. The Contractor is currently bypassing the plant influent to complete critical work, with the bypass expected to remain in place through December.

Contract 24-11: Above-Ground Fuel Storage Tank Replacements: A new Above-Ground Fuel Storage Tank (AST) is now operational at the Hopewell Wastewater Treatment Plant. The contractor is finalizing permitting, and staff are coordinating with PSE&G on the temporary removal of power lines to facilitate the replacement of the AST at the South Brunswick Pump Station.

Contract 25-1: Thickener No. 2 Improvements Project: Staff received sludge thickening equipment submittals from VNL on November 2, 2025. Staff is reviewing the submittals. Delivery of materials and equipment is projected for March 2026. Concrete repair is scheduled to take place in November.

*Project 22-2 GE 90-30 PLC Upgrade:* No additional progress has been made during this reporting period.

*Project 24-10: RRWWTP Fire Hydrant Replacements:* Staff are working to locate and assess the additional leak and determine necessary repairs. The investigation has been scheduled for Thursday, November 13, 2025.

*Project 25-4: Millstone Pump Station Variable Frequency Drives Replacement:* Installation of new Yaskawa U1000 Variable Frequency Drives (VFD) at the Millstone Pump Station are complete. Pumping systems are fully operational.

## Treasurer's Report

Mr. Mazich reported a net income of \$2,117,281 for the 2025 fiscal year to date. The Authority has total cash and investments of \$21,765,347. The current fund source for the capital project is \$9,147,225, and the construction projects balance is \$3,520,982; there are sufficient funds for these projects. The outstanding bond principal balance is \$27,890,299. The New Jersey Cash Management yield is 4.10%.

Mr. Goldfarb stated that the Finance Committee recently met and discussed budget transfers and the capital budget. Mr. Goldfarb and Ms. Alexander agreed to meet to discuss the law pertaining to such. A discussion occurred regarding the management of revenues and expenses.

Mr. Mazich reported that there are no customers with overdue balances.

## Cash Management Plan of Stony Brook Regional Sewerage Authority in the County of Mercer, New Jersey

## I. Statement of Purpose

This Cash Management Plan (the "Plan") is prepared pursuant to the provisions of N.J.S.A. 40A:5-14 in order to set forth the basis for the deposits ("Deposits") and investment ("Permitted Investments") of certain public funds of Stony Brook Regional Sewerage Authority ("SBRSA") pending the use of such funds for the intended purposes. The Plan is intended to assure that all public funds identified herein are deposited in interest bearing Deposits or otherwise invested in Permitted Investments hereinafter referred to. The intent of the Plan is to provide that the decisions made with regard to the Deposits and the Permitted Investments will be done to ensure the safety, the liquidity (regarding its availability for the intended purposes), and the maximum investment return within such limits. The Plan is intended to ensure that any Deposit or Permitted Investment matures within the time period that approximates the prospective need for the funds deposited or invested so that there is not a risk to the market value of such Deposits or Permitted Investments.

## II. Identification of Funds and Accounts to be Covered by the Plan

The Plan is intended to cover the deposit and/or investment of all accounts of the SBRSA

# III. <u>Designations of Officials of SBRSA Authorized to Make Deposits and Investments Under the Plan</u>

Appointment of Authorized Representatives which includes The Chairman, Treasurer, Executive Director and Finance Director (individually or collectively, "Designated Official(s)"). Prior to making any such Deposits or any Permitted Investments, such officials of the SBRSA are directed to supply to all depositories or any other parties with whom the Deposits or Permitted Investments are made, a written copy of this Plan which shall be acknowledged in writing by such parties and a copy of such acknowledgment kept on file with such officials.

#### IV. Designation of Depositories

The following banks and financial institutions are hereby designated as official depositories for the Deposit of all public funds referred to in the Plan, including any certificates of deposit.

- Bank of America
- State Street Bank (New Jersey Cash Management Fund)
- US Bank
- Wells Fargo Bank

Any other bank meeting the requirements of the Governmental Unit Deposit Protection Act, N.J.S.A. 17:9-41, et seq. ("GUDPA")

All funds shall be deposited within 48 hours of receipt to maximize interest earnings. All such depositories shall acknowledge in writing receipt of this Plan by sending a copy of such acknowledgment to the Designated Official(s) referred to in Section III above.

# V. <u>Designation of Brokerage Firms and Dealers with Whom the Designated Officials May Deal</u>

The following brokerage firms and/or dealers and other institutions are hereby designated as firms with whom the Designated Official(s) of the SBRSA referred to in this Plan may deal for purposes of buying and selling securities identified in this Plan as Permitted Investments or otherwise providing for Deposits. All such brokerage firms and/or dealers shall acknowledge in writing receipt of this Plan by sending a copy of such acknowledgment to the Designated Official(s) referred to in Section III above.

- New Jersey Asset & Rebate Management Program (fixed-term investments)
- Wells Fargo Securities (US Treasury Bills)

## VI. Authorized Investments

- A. Except as otherwise specifically provided for herein, the Designated Official is hereby authorized to invest the public funds covered by this Plan, to the extent not otherwise held in Deposits, in the following Permitted Investments:
  - (1) Bonds or other obligations of the United States of America or obligations guaranteed by the United States of America;
  - (2) Government money market mutual funds;
  - (3) Any obligation that a federal agency or a federal instrumentality has issued in accordance with an act of Congress, which security has a maturity date not greater than 397 days from the date of purchase, provided that such obligation bears a fixed rate of interest not dependent on any index or other external factor;
  - (4) Bonds or other obligations of the Local Unit or bonds or other obligations of school districts of which the Local Unit is a part or within which the school district is located;
  - (5) Bonds or other obligations, having a maturity date not more than 397 days from the date of purchase, approved by the Division of Investment of the Department of the Treasury for investment by local units;
  - (6) Local government investment pools;
  - (7) Deposits with the State of New Jersey Cash Management Fund established pursuant to section 1 of P.L. 1977, c.281 (C.52:18A-90.4); or

- (8) Agreements for the repurchase of fully collateralized securities if:
  - (a) the underlying securities are permitted investments pursuant to paragraphs (1) and (3) of this subsection A:
  - **(b)** the custody of collateral is transferred to a third party
  - (c) the maturity of the agreement is not more than 30 days;
  - (d) the underlying securities are purchased through a public depository as defined in section 1 of P.L.1970, c.236 (C.17:9-41); and
  - (e) a master repurchase agreement providing for the custody and security of collateral is executed.

For purposes of the above language, the terms "government money market mutual fund" and "local government investment pool" shall have the following definitions:

#### **Government Money Market Mutual Fund**

An investment company or investment trust:

- (a) which is registered with the Securities and Exchange Commission under the "Investment Company Act of 1940," 15 U.S.C. sec. 80a-operated in accordance with 17 C.F.R. sec. 270.2a-7.
- (b) the portfolio of which is limited to U.S. Government securities that meet the definition of any eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities; and
- (c) which has:
  - (i) attained the highest ranking or the highest letter and numerical rating of a nationally recognized statistical rating organization; or
  - (ii) retained an investment advisor registered or exempt from registration with the Securities and Exchange Commission pursuant to the "Investment Advisors Act of 1940," 15 U.S.C. sec. 80b-1 et seq., with experience investing in U.S. Government securities for at least the most recent past 60 months and with assets under management in excess of \$500 million.

#### **Local Government Investment Pool**

An investment pool:

- (a) which is managed in accordance with 17 C.F.R. sec. 270.2a-7;
- (b) which is rated in the highest category by a nationally recognized statistical rating organization;
- (c) which is limited to U.S. Government securities that meet the definition of an eligible security pursuant to 17 C.F.R. sec. 270.2a-7 and repurchase agreements that are collateralized by such U.S. Government securities;

- (d) which is in compliance with rules adopted pursuant to the "Administrative Procedure Act," P.L. 1968, c.410 (c.52:14B-1 et seq.) by the Local Finance Board of the Division of Local Government Services in the Department of Community Affairs, which rules shall provide for disclosure and reporting requirements, and other provisions deemed necessary by the board to provide for the safety, liquidity and yield of the investments;
- (e) which does not permit investments in instruments that: are subject to high price volatility with changing market conditions; cannot reasonably be expected, at the time of interest rate adjustment, to have a market value that approximates their par value; or utilize an index that does not support a stable net asset value; and
- (f) which purchases and redeems investments directly from the issuer, government money market mutual fund, or the State of New Jersey Cash Management Fund, or through the use of a national or State bank located within this state, or through a broker-dealer which, at the time of purchase or redemption, has been registered continuously for a period of at least two years pursuant to section 9 of P.L. 1967 c.9 (C.49:3-56) and has at least \$25 million in capital stock (or equivalent capitalization if not a corporation), surplus reserves for contingencies and undivided profits, or through a securities dealer who makes primary markets in U.S. Government securities and reports daily to the Federal Reserve Bank of New York its position in and borrowing on such U.S. Government securities.

#### VIII. Safekeeping, Custody, Payment and Acknowledgement of Receipt of Plan

To the extent that any Deposit or Permitted Investment involves a document or security which is not physically held by the SBRSA, then such instrument or security shall be covered by a custodial agreement with an independent third party, which shall be a bank or financial institution in the State of New Jersey. Such institution shall provide for the designation of such investments in the name of the SBRSA to assure that there is no unauthorized use of the funds or the Permitted Investments or Deposits. Purchase of any Permitted Investments that involve securities shall be executed by a "delivery versus payment" method to ensure that such Permitted Investments are either received by the SBRSA or by a third-party custodian prior to or upon the release of the SBRSA's funds.

To assure that all parties with whom the SBRSA deals either by way of Deposits or Permitted Investments are aware of the authority and the limits set forth in this Plan, all such parties shall be supplied with a copy of this Plan in writing and all such parties shall acknowledge the receipt of that Plan in writing, a copy of which shall be on file with the Designated Official(s).

#### **IX.** Reporting Requirements

For each month during which this Plan is in effect, the Designated Official(s) referred to in Section III hereof shall supply to the governing body of the SBRSA a written report of any Deposits or Permitted Investments made pursuant to this Plan, which shall include, at a minimum, the following information:

- A. The name of any institution holding funds of the SBRSA as a deposit or a Permitted Investment.
- B. The amount of securities or Deposits purchased or sold during the immediately preceding month.
- C. The class or type of securities purchased, or Deposits made.
- D. The book value of such Deposits or Permitted Investments.
- E. The earned income on such Deposits or Permitted Investments. To the extent that such amounts are actually earned at maturity, this report shall provide an accrual of such earnings during the immediately preceding month.
- F. The fees incurred to undertake such Deposits or Permitted Investments.
- G. The market value of all Deposits or Permitted Investments as of the end of the immediately preceding month.
- H. All other information which may be deemed reasonable from time to time by the governing body of the SBRSA.

### **Term of Plan**

This Plan shall be in effect from December 1, 2025 to November 30, 2026. Attached to this Plan is a resolution of the governing body of the SBRSA approving this Plan for such period of time. The Plan may be amended from time to time. To the extent that any amendment is adopted by the governing body of the SBRSA, the Designated Official is directed to supply copies of the amendments to all of the parties who otherwise have received a copy of the originally approved Plan, which amendment shall be acknowledged in writing in the same manner as the original Plan was so acknowledged.

**WHEREAS,** the Authority desires to award a contract to Trojan Technologies for the purchase of replacement UV parts; and

### Resolution Authorizing and Extension of the Shared Services Agreement with the Atlantic County Utilities Authority for Sludge Disposal

WHEREAS, the Stony Brook Regional Sewerage Authority (Authority) has determined that, to ensure the continued operation of the Authority System, it must maintain provisions for the hauling of cake sludge to off-site locations for disposal at times when the incinerator system is being shut down for scheduled maintenance or temporarily placed out of service to fix mechanical/structural problems; and

**WHEREAS,** as the Authority requires a reliable location for off-site sludge disposal, to which the Authority has executed a Shared Services Agreement with the Atlantic County Utilities Authority through Resolution 2023-125 for the purpose of providing a reliable means of sludge cake disposal for the Authority; and

WHEREAS, the Shared Services Agreement commenced on January 1, 2024 and will terminate on December 31, 2024. If not otherwise terminated, the Shared Services Agreement is automatically extended for four (4) additional periods of one year, at an increase in cost not greater than the percentage increase in the Consumer Price Index for Urban Consumers for the Philadelphia-Wilmington-Atlantic City standard metropolitan statistical area, as determined by the United States Department of Labor, Bureau of Labor Statistics for December of the additional contract year over December of the preceding contract year; and

WHEREAS, the Authority has received formal correspondence from the Atlantic County Utilities Authority indicating a 3.32% increase in disposal fees effective January 1, 2025 per the Shared Services Agreement; and

**WHEREAS,** the Authority recommends extending the Shared Services Agreement for an additional year at the following rates (excluding transportation costs) that will apply effective January 1, 2025 thru December 31, 2025:

### Dry Solid by Weight

Sludge Cake > 24.1% - Cubic yard	\$48.48 per cubic yd.
Sludge Cake 20.01 – 24% - Cubic yard	\$62.02 per cubic yd.
Sludge Cake 18.01 – 20% - Cubic yard	\$73.15 per cubic yd.
Sludge Cake 16 – 18% - Cubic yard	\$85.98 per cubic yd.
Sludge Cake < 16% - Cubic yard	\$131.09 per cubic yd

**WHEREAS,** in accordance with the Uniform Shared Services Act (N.J.S.A. 40A:65-1 et seq.), the Atlantic County Utilities Authority and the Authority are authorized and empowered to enter into an Agreement for the disposal of sludge; and

NOW, THEREFORE, BE IT RESOLVED by the Stony Brook Regional Sewerage Authority that the Executive Director is hereby authorized and directed to extend the Shared Services Agreement with the Atlantic County Utilities Authority for Sludge Disposal for the disposal of its cake sludge, to be funded out of the Authority's Operating Budget. The Shared Services Agreement is subject to the availability and appropriation annually of sufficient funds as may be required to meet SBRSA's financial obligations, and the executed Shared Services Agreement shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs, pursuant to rules and regulations promulgated by the Director.
