Sealed Bids for Stony Brook Regional Sewerage Authority, River Road Meter Station Number 6 Rehabilitation Project, Contract 25-11 will be received at the office of the Stony Brook Regional Sewerage Authority, 290 River Road, Princeton, New Jersey 08540 until 2:00 p.m. prevailing time, December 4, 2025, at which place and time said Bids will be publicly opened and read aloud.

The work includes the heavy power washing and complete three stage epoxy recoating of the interior of the station, all metallic surfaces, primarily aluminum — will be cleaned, some areas of spalling concrete will be repaired, access ladder to be removed, cleaned and reinstalled with new stainless steel bolts and fasteners, removal of existing access hatch and replacement of air tight access hatch, removal and disposal of the interior fan and humidifier, installation of a new fan (mounted on the exterior) with a new electrical connection to the existing interior lighting and the new fan and air piping located at the Stony Brook Regional Sewerage Authority's River Road Meter Station 6, located on Alexander Road, Princeton, NJ 08540. Across the street from 426 Basin Street, Princeton.

There will be a site visit to the Meter Station 6, Alexander Road, Princeton, New Jersey, on November 18, 2025, at 9:30 a.m. It is recommended that all interested bidders attend.

Certified, Treasurer's or Cashier's Check or bid bond in the sum of 10 percent of the bid, but in no case in excess of \$20,000, Agreement of Surety, Surety Disclosure Statement and Certification (if bid amount is greater than or equal to \$800,000), List of Subcontractors, Ownership Disclosure, Bidder's Affidavit, Non-Collusion Affidavit, References, Acknowledgement of Receipt of Changes, Bidders Check List, and Questionnaire are required with each Bid.

Bidders shall not remove and submit the Bid pages separate from the volume of Contract Documents, but shall submit their Bid bound with the complete volume of attached Contract Documents, including all pages correctly assembled and all Addenda attached.

Contract Documents may be examined and obtained at the office of the Stony Brook Regional Sewerage Authority, 290 River Road, Princeton, New Jersey 08540. A non-refundable payment of \$50 by check made payable to the Stony Brook Regional Sewerage Authority will be required on each set of Contract Documents taken.

In the event that a potential bidder obtains the Contract Documents in any manner other than as specified herein, the Stony Brook Regional Sewerage Authority will not have the contact information of the potential bidder for purposes of issuing bid addenda, if any. The non-receipt of any addenda (in the event that any addenda are issued) and the failure of the bidder to acknowledge the receipt of any and all addenda at the time of bid shall be considered a fatal defect in such Bidder's submission and said Bid shall be immediately rejected. Therefore, if a potential bidder obtains the Bid Documents in any manner other than as specified herein, said Bidder shall promptly provide written notice to the Stony Brook Regional Sewerage Authority of its name, mailing address and email address.

Successful bidder must furnish 100 percent Performance and Payment Bond in the form required by N.J.S.A. 2A:44-147.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and, N.J.A.C. 17:27.

The Owner reserves the right to reject all Bids pursuant to N.J.S.A. 40A:11-13.2 and N.J.A.C. 7:22-9.10(a).
