Sealed Bids for Stony Brook Regional Sewerage Authority, Regenerative Thermal Oxidizer Valve Replacement Project will be received at the office of the Stony Brook Regional Sewerage Authority, 290 River Road, Princeton, New Jersey 08540 until **2:00 pm** prevailing time, **September 23, 2025** at which place and time said Bids will be publicly opened and read aloud.

The work includes the replacement of internal heat recover media for the Regenerative Afterburner (RTO), replacement of the forced draft fan including the motor and base, and all associated work for the RTO and Incineration systems to function. The work is located at the Stony Brook Regional Sewerage Authority River Road Wastewater Treatment Plant located at 290 River Road, Princeton, New Jersey 08540.

Any bidders may request a site visit to the River Road Wastewater Treatment Plant to view the RTO however note that it will continue to remain in operation so internal media will not be accessible.

Certified, Treasurer's or Cashier's Check or bid bond in the sum of 10 percent of the bid, but in no case in excess of \$20,000, Agreement of Surety, List of Subcontractors, Ownership Disclosure, Bidder's Affidavit, Non-Collusion Affidavit, References, Acknowledgement of Receipt of Notices, Revisions or addenda to Bid Documents Form, Investment Activities in Iran Disclosure, Bidder's Checklist, and Questionnaire are required with each Bid.

Bidders should not remove and submit the Bid pages separate from the volume of Contract Documents but should submit their Bid bound with the complete volume of attached Contract Documents, including all pages correctly assembled and all Addenda attached.

Contract Documents may be examined and obtained at the office of the Stony Brook Regional Sewerage Authority, 290 River Road, Princeton, New Jersey 08540. A non-refundable payment of \$25.00 by check made payable to the Stony Brook Regional Sewerage Authority will be required on each set of Contract Documents taken.

Successful bidder must furnish 100 percent Performance Bond and 100 percent Labor and Materials Bond in the combined form required by N.J.S.A. 2A:44-147.

In accordance with the provisions of N.J.S.A. 58:11B-26, N.J.A.C. 7:22-3.17(a)24 and 4.17(a)24, the contractor (subcontractor) shall comply with all of the provisions of N.J.A.C. 7:22-9.

Bidders are required to comply with the requirements of N.J.S.A. 10:5-31 et seq. and N.J.A.C. 17:27

The Owner reserves the right to reject all Bids pursuant to N.J.S.A. 40A:11-13.2 and N.J.A.C. 7:22-9.10(a).
